Purchaser agrees that it shall have no rights against Cinemark from the purchase of Supersavers other than reimbursement of their purchase price in the event of a breach of Cinemark's obligations herein.

Any breach of these rules will immediately invalidate all of the Supersavers purchased hereby, result in forfeiture of their purchase price or admission rights, and subject Purchaser to legal action.
